Obligations and rules of conduct for the visitors (spectators) at the WorldSkills Kazan 2019 venues

During the WorldSkills Kazan 2019 the visitors (spectators) **SHALL**:

- a) show entrance tickets when entering the Competition venue, take an individual spectator seat specified in the entrance ticket or the document that replaces it, except for the cases when the ticket or the document that replaces it does not guarantee taking an individual spectator seat;
- b) when they walk or drive to the official Competition venue and/or to the adjoining territory, go through personal examination and provide personal belongings for examination;
- c) leave bulky objects at the locker room, except for the cases when carrying of bulky objects to the Competition venue has been approved by the Competition Organizer;
- d) comply with public order and the requirements set forth in these Rules while at the Competition venue;
- d) show respect to other visitors (spectators), organizers and participants of the Competition, and persons that ensure maintenance of public order and public security at the Competition venues;
- e) immediately inform the persons that ensure maintenance of public order and public security during the Competition, about detection of suspicious objects, violation of public order, appearance of smoke or fire, necessity to provide medical assistance to persons present at the Competition venues;
- f) refrain from doing property damage to other visitors (spectators), Competition organizers and participants, and persons that ensure maintenance of public order and public security during the Competition, treat the property of the venue carefully, and commit no nuisance:
- g) comply with legal requirements of the representatives of the Competition organizer other persons that ensure maintenance of public order and public security during the Competition;
- h) when informed about the evacuation from the Competition venue, act in accordance with the instructions (orders) of the persons that ensure maintenance of public order and public security during the Competition, in accordance with fire safety requirements and the approved evacuation plan, keeping calm and refraining from panicking.

While at the Competition venues, visitors (spectators) are **PROHIBITED TO:**

- a) be in the state of intoxication that insults human dignity and public morality;
- b) perform actions that threaten personal security, life, health, as well as security, life and health of other persons at the Competition venue or in the adjacent territory;
- c) throw objects in the direction of other visitors (spectators), participants of the Competition or other persons present at the Competition venue or in the adjacent territory;
- d) insult other persons (including with the use of banners, posters, placards and other means of visual propaganda) and perform other actions that discredit the honour, dignity or business reputation or aimed at stirring up hatred or hostility, as well as humiliating the dignity of a person or a group of persons by gender, race, nationality, language, origin, attitude to religion;

- e) hide faces, including with the use of masks, except for the cases specially provided for by the Competition Organizer, as well as masking means and other objects to be used especially for the difficulty of identification;
- f) violate public morals and standards of behaviour by exposure of intimate body parts while at the Competition venues;
- g) penetrate the venue of the Competition venue or the adjacent territory, as well as to the zones not specified in the entrance ticket or the document that replaces it (technical premises, zones for VIP guests, seats for mass media), access to which is limited by the Competition organizer;
- h) stay in stairways during the Competition, disturb movement in the zones of official Competition venues intended for evacuation, including aisles, exits and entrances (main and emergency ones);
- i) make inscriptions and drawings on the structures, buildings, facilities located at the Competition venues, and locate foreign objects near them without a relevant permit of the Competition Organizer;
- j) come to the Competition venue with animals and birds, except for guide dogs in muzzles;
 - k) hold public events not mentioned in the Competition regulations;
- 1) bring and use the items as per the List of prohibited items on the territory of the WorldSkills Kazan 2019 venues;
- m) engage in illegal trade (including selling of entrance tickets or documents that replace them), distribute the products of political, religious and racist nature (including posters, flyers, booklets) in any way.

The persons that do not comply with the requirements set forth in these Rules, or refuse to comply with them, shall not be admitted to the Competition venues, may be removed from them or made liable in accordance with the laws of the Russian Federation.
